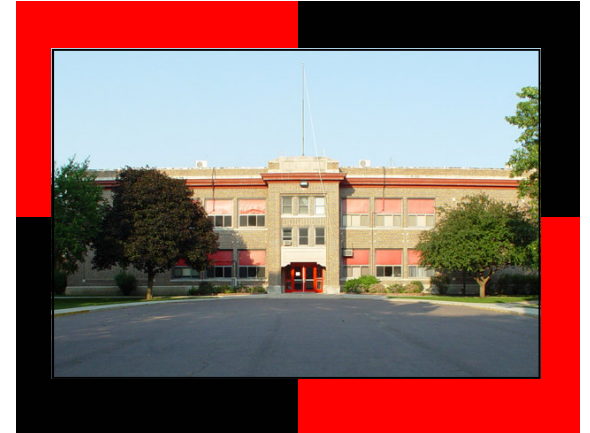

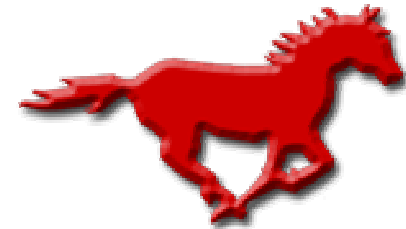

HISTORY & PURPOSE

The Foundation is a legal nonprofit entity founded in July of 2003 to combine the successful Foundations of George and Little Rock. It has been chartered by the State of Iowa and is recognized by the Internal Revenue Service as a valid recipient of tax free gifts.



The purposes of the George-Little Rock Community School Educational Foundation are to maintain, develop, and extend the facilities, services, and resources of the George-Little Rock School District. We also wish to provide broader educational service opportunities to our students, staff, faculty and residents of the district's geographical area.



All of the assets, earnings, and income from any source of the George-Little Rock Community School Foundation shall be used exclusively to maintain and enhance both the academic and co-curricular programs. The following are some specific areas that may be addressed with use of Foundation funds in the future:

- Improvements in Technology
- Improvements in Fine Arts (Music and Theater)
- Scholarships

Individuals may also designate funds for use in specific areas if they so desire.

TYPES OF GIFTS ACCEPTED
